



## January 22, 2015 Minutes

**CALL TO ORDER**– Past Chair Joe Hauryski called the meeting to order at 4:25 PM in the STC Conference room.

**WELCOME AND INTRODUCTIONS** – Mr. Hauryski welcomed all to the meeting.

**APPROVAL OF MINUTES** – On a motion duly made (Alger/VanEtten) and carried, the minutes of the November 20, 2014 meeting were approved.

**PRESENTATION** – Dr. Kate Douglas, President, Corning Community College, gave a presentation outlining the college’s facilities master plan for the next 5 years. Board members were particularly interested in job training, suggesting partnering with industry to ensure that machinists, for example, are trained on the equipment that industry is using. Also, the upgrade to the college’s athletic facilities received praise from the board.

### **COMMITTEE REPORTS**

#### 1. **Audit Committee**

- a) **Abstract of Claims** – the audit committee reviewed abstracts totaling \$28,786.05. On a motion duly made (VanEtten/Hartman) and carried, the abstracts were approved.

#### 2. **Budget and Personnel**

- a) **ARC Funding** – The committee discussed the ARC funds that in 2014 were designated for a new STC program to benefit municipalities. The program, known as the Planning School, is continuing in 2015 and will include additional services to assist municipalities in planning and government efficiencies.

## **REGIONAL PROGRAM ACTIVITIES**

1. **Appalachian Regional Commission (ARC) Project Update** – Victoria Ehlen reviewed the ARC project status report (attached), receiving feedback from board members about projects that are still underway.
2. **Development District Association of Appalachia Annual Conference** – Marcia Weber asked board members to accompany STC staff to the Development District Association of Appalachia (DDAA) Conference in Washington, DC on March 22-24, 2015. STC provides transportation and pays the expenses, and the conference is educational and worth attending.
3. **Updates on STC Appalachian Regional Commission Project Review Cycle** - The review cycle this year will be in June and July, with projects due in the STC office by June 23, 2015 and ratings approved at the STC July 16 board meeting. Anyone with a potential project should talk to Victoria Ehlen about eligibility and plan to submit a one page project summary with contact information to STC by the end of May.
4. **STC Interstate 86 (I-86) Resolution** - Ted Bennett presented a resolution for STC board approval, requesting that NYS advance funding and expedite completion of I-86 projects. On a motion duly made (VanEtten/Olthof) and carried, the I-86 resolution (attached) was approved.

**RESOLUTION OF THE SOUTHERN TIER CENTRAL REGIONAL PLANNING AND DEVELOPMENT BOARD URGING GOVERNOR CUOMO AND THE NEW YORK STATE LEGISLATURE TO ADVANCE FUNDING AND EXPEDITE COMPLETION OF THE INTERSTATE 86 PROJECTS IN BROOME, DELAWARE, SULLIVAN, AND ORANGE COUNTIES**

WHEREAS, Governor Pataki committed to a ten-to-twelve year construction program to complete the Route 17 conversion to I-86 beginning with the first designation (177 miles Chemung County west to Pennsylvania) on December 3, 1999; and

WHEREAS, the designation of New York State Route 17 to I-86 provides a highway network with connection to every Interstate Highway located within New York State and Interstate Highways leading into Pennsylvania; and

WHEREAS, the upgrade and designation of Route 17 as I-86 will make the region more competitive and able to attract substantial growth in business, industry, and tourism as well as improve the safety of the traveling public; and

WHEREAS, the New York I-86 Economic Development Benefit Study, issued in January 2000 and widely accepted and quoted at all levels of government, called for an aggressive eight-year construction period that would result in a 3.2 billion dollar direct economic benefit to communities along the I-86 Highway Corridor once the conversion has been completed; and

WHEREAS, with proper funding and resources (Fast Track/Design Build) for the remaining projects in Broome, Delaware, Sullivan, and Orange Counties, the conversion of Route 17 to I-86 could be completed many years sooner than on the present schedule, providing vast economic benefits to the Hudson Valley, Southern Tier, and Western New York regions and yielding significant economic benefits for the nation by facilitating national freight flows, reducing travel times, improving safety, and enhancing access to markets; completion would create new jobs and greater value-added activity; and

WHEREAS, the New York State Department of Transportation in the latest update to its capital program proposes to delay to 2017 the first stage of the two stage Exit 131 reconstruction project which was to have begun in 2013; and

WHEREAS, the Exit 131 reconstruction project will address critical traffic control and safety needs in the region due to the expected reductions in severe traffic delays and congestion arising near this connection to the New York State Thruway (I-87/Harriman) and New York State Route 17 (future I-86); and

WHEREAS, the New York State Department of Transportation has also proposed to delay construction to Exit 122 (State Route 3 westbound ramps) to 2017; now, therefore, be it

RESOLVED, that the Southern Tier Central Regional Planning and Development Board does hereby request Governor Andrew Cuomo and the New York State Legislature to advance funding (Fast Track/Design Build), expediting completion of the projects in Broome, Delaware, Sullivan, and Orange Counties on New York State Route 17 so that the same may be converted to Interstate Route 86; and, be it further
